At December 31, 2021, a total of 9,185 acres have been protected by 61 conservation easements, which conservatively represents over \$35.6 million in value.**

a qualified conservation organization. Conservation easements represent a perpetual restriction on the use of the land without transfer of ownership of the underlying property. The Trust acquires conservation easements through donations from property owners. The Trust does not record the conservation easements in its assets.

The Trust charges the landowner project fees to facilitate the transaction. A portion of the project fee is designated to support the perpetual stewardship and legal defense of the easement. The Trust recognizes revenue from project fees as costs are incurred and the project is completed. Fees received in advance are deferred to future periods in which costs are incurred.

**Board-designated Endowment:** Board reserve for stewardship and legal defense of conservation easements, general conservation, and education.
