The Trust continued the dialog with County residents and visitors regarding conservation easements. The Trust became nationally accredited by the Land Trust Accreditation Commission. At December 31, 2019, a total of 8,911 acres have been protected by 60 conservation easements, which conservatively represents over \$35.5 million in value.
